The contractor/agency is to satisfy the following conditions. Failing which the tender is liable for rejection.

Pre-qualification criteria of the agency (to be furnished along with technical bid document duly filled up).

1.1 Contractor's registration:

- (a) Self-attested up to date (renewed) contractor's registration certificate of appropriate class and category issued by the competent authority, (b) valid electrical contract license, (c) Valid electrical supervisory license issued by the competent authority.

2.1 Experience of having successfully completed similar nature of works during last 7 years ending last day of the month previous to the one in which applications are invited:

(i) Three works each costing not less than the amount equal to 40% of the estimated cost of work.

Or

(ii) Two works each costing not less than the amount equal to 60% of the estimated cost of work.

or

(iii) One works each costing not less than the amount equal to 80% of the estimated cost of work.

And

Completion certificate for the construction of similar work(s) should be in prescribed format given in Form-E of the technical bid document issued by the officer not below the rank of Executive Engineer of Govt./Semi Govt. Department.

3.1 Average annual financial turnover:

Average annual financial turnover on construction works should be at least 50% of the Estimated Cost during last 3 consecutive financial year ending 2022-23 duly signed by the Chattered accountant.

4.1 Banker certificate:

Banker certificate issued by the Scheduled Bank as per proforma given in technical bid document (Form B) for amount not below 40% of Estimated cost during current financial year.

(i) Bankers certificates should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.

(ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.

5.1 G.S.T registration:

Self-attested copy of G.S.T registration certificate (along with Annexure A &B). The agency should submit the GSTR-3B return along with payment receipt for the month of September, 2024.

6.1 EPF registration:

Self-attested copy of EPF registration certificate including paid challan (not less than the minimum value) for the month of November, 2024.

7.1 ESIC registration:

Self-attested copy of ESIC registration certificate including paid challan for the month of November, 2024.

8.1 PAN No.:


Self-attested copy of PAN card.

9.1 An Engineer (Electrical) ,diploma with minimum five years' experience in the required field or B.E./B.Tech (El) must be engaged by the contractor (Whose certificate duly self-attested, one copy photo & an undertaking by the Engineer in original is to be enclosed with the technical bid failing which the tender will not be considered) to supervise the work. The Engineer engaged must be familiar with all the works specified in the contract & must be acquainted with CPWD specification, manual etc. The engagement of engineer is not mandatory for Contractor possessing technical qualification.

10.1 Partnership deed:

Self-attested copy of partnership deed in case of partnership firms, articles/memorandum of association in case of company.

11.1 Power of attorney:



The agency has to submit tender document signing authorization/power of attorney (for other than proprietorship firm)
