The contractor/agency is to satisfy the following conditions. Failing which the tender is liable for rejection.

Pre-qualification criteria of the agency (to be furnished along with technical bid document duly filled up)



1. Contractor's Registration Certificate (CRC) or Societies act registration valid for the year 2024-25 or MSME registered agencies are also eligible as per applicable norms.
2. Experience of having successfully completed similar nature of works (gardening/housekeeping services) of the following magnitude during last 7 years ending last day of the month previous to the one in which applications are invited:

(i) Three works each costing not less than the amount Rs. 39,20,000.00.

Or

(ii) Two works each costing not less than the amount Rs. 58,80,000.00.

or

(iii) One works each costing not less than the amount Rs. 78,40,000.00.

And

One completed work (either part of above or a separate one) costing not less than Rs. 39,20,000.00 with some Central/State Government Organization/Central Autonomous Body/Central Public Sector Undertaking.

Completion certificate for the similar work(s) means Gardening/Housekeeping work only should be in prescribed format given in Section – 6 (IV) of the technical bid document issued by the officer not below the rank of Executive Engineer of Govt./Semi Govt. Department or the Head of Office / Institution.

3. Self attested copy of GST registration certificate. Agency / Firm should submit GSTR-3B return for the month of June, 2024 along-with copy of paid challan. Supporting document (s) which justifies that the firm is registered under GST for providing Housekeeping/Gardening services.
4. Self attested copy of EPF registration certificate including paid challan for the month of June, 2024. Applied for EPF registration is not valid. Compliance Certificate issued by the concerned EPF authority of the State is to be submitted.
5. Proof of registration with ESI Authorities along with Registration Number and up to date payment slip towards contribution.
6. Financial solvency certificate issued by the Scheduled Bank in Original as per CPWD format for amount not below Rs. 39.20 Lakh during current financial year i.e, 2024-25.

(i) Bankers certificates should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.

(ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.

6. Annual financial turnover:

Average annual financial turnover on housekeeping / gardening should not be less than Rs. 49.00 Lakh during last 3 consecutive financial year ending 2023-24. Audited balance sheet duly signed by chartered account should be submitted.

7. Xerox copy of PAN card in the name Firm / Societies / Individual firm.

8. Application form & Declaration(s), as mentioned in the tender document.

9. Bank details.

10. Tender paper signing authorization in Original in case of partnership firm / company.

11. Xerox copy of Partnership deed in case of Partnership firm.

12. Only a Company having its own Head Office/ Branch Office in Assam should apply (Proof to be submitted). All communications to be made only to this office.

13. Xerox copy of registered company memorandum of understanding mentioning name of all the partners in case of Company / firm.

The lump sum Earnest Money Deposit (EMD) of Rs. 1,96,000.00/- (Rupees One Lakh Ninety Six Thousand only) for (refundable) to be transferred through online.

The successful contractor will be required to deposit **Performance Guarantee @ 5% of the awarded value to be calculated yearly** in the form of a Bank Guarantee / Fixed Deposit from any scheduled Bank of India, in favour of the Director, NIT Silchar payable at SBI, NIT Silchar within 15 (fifteen) days from the date of issue of work order. The successful contractor will be required to submit valid labour license issued from Central Labour Commissioner (Central), under Silchar jurisdiction for final award of work along with Compliance Certificate from the office of EPF Commissioner.



Tender of any contractor not accompanied with proper earnest money and incomplete tender, non-submission of requisite documents (self-attested) under Sl. 1 to 13 of the NIT or in any form shall be summarily rejected.

If any, holidays/strike falls during the notified days, the process will be continued on next working day.

The Director, NIT Silchar reserves the right to accept or reject at any or all the tenders without assigning any reason. Performance will be reviewed every 6 months for further continuation based on the report of the performance review committee of the Institute.
