Duly filled in tender documents must be submitted along with EMD (through online), and the self attested copies of the following certificates, issued by the competent authority.

1. Contractor's Registration Certificate (CRC) or Societies act registration valid for the year 2021-22 or MSME registered agencies are also eligible as per applicable norms.
2. Experience of having successfully completed similar nature of works during last 7 years ending last day of the month previous to the one in which applications are invited:

(i) Three works each costing not less than the amount equal to 40% of the estimated cost of work.

Or

(ii) Two works each costing not less than the amount equal to 60% of the estimated cost of work.

or

(iii) One works each costing not less than the amount equal to 80% of the estimated cost of work.

And

One completed work (either part of above or a separate one) costing not less than the amount equal to 40% of the estimated cost with some Central/State Government Organization/Central Autonomous Body/Central Public Sector Undertaking in north eastern states.

Completion certificate for the similar work(s) means Housekeeping work only should be in prescribed format given in Section – 6 (IV) of the technical bid document issued by the officer not below the rank of Executive Engineer of Govt./Semi Govt. Department or the Head of Office / Institution.

3. Self attested copy of GST registration certificate. Agency / Firm should submit GSTR-3B return for the month of December, 2021 along-with copy of paid challan. Supporting document (s) which justifies that the firm is registered under GST for providing Housekeeping services.
4. Self attested copy of EPF registration certificate including challan for the month of February, 2022 in any central government organization with document of evidence. Applied for EPF registration is not valid.
5. Financial solvency certificate issued by the Scheduled Bank as per CPWD format for amount not the 40% of the Estimated cost i.e, Rs. 84,00,000.00 during current financial year i.e, 2021-22.
  - (i) Bankers certificates should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.
  - (ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.
6. Average annual financial turnover:

Average annual financial turnover on housekeeping should not be less than 50% of the estimated cost i.e, Rs. 105.00 Lakh during last 3 consecutive financial year ending 2020-21. Audited balance sheet duly signed by chartered account should be submitted.
7. The agency should submit the No Objection Certificate from Central Labour Commissioner (Central), under Silchar jurisdiction for participate the tender & award of work.
8. The agency should submit the No Objection Certificate from EPF Commissioner (Central), under Silchar jurisdiction for participate the tender & award of work.



9. Xerox copy of PAN card in the name Firm / Societies / Individual firm.
10. Application form & Declaration(s), as mentioned in the tender document.
11. Bank details.
12. Tender paper signing authorization in Original in case of partnership firm / company.
13. Xerox copy of Partnership deed in case of Partnership firm.
14. Xerox copy of registered company memorandum of understanding mentioning name of all the partners in case of Company / firm.

The lump sum Earnest Money Deposit (EMD) of **Rs. 4,00,000.00/-** (Rupees Four Lakh only) for (refundable) to be transferred through online.

The successful contractor will be required to deposit **Performance Guarantee @ 5% of the awarded value to be calculated yearly** in the form of a Bank Guarantee / Fixed Deposit from any scheduled Bank of India, in favour of the Director, NIT Silchar payable at SBI, NIT Silchar within 15 (fifteen) days from the date of issue of work order.

The institute reserve the right to accept or reject any application for the issue of tender document without assigning any reasons, thereon.

The "Technical Bid" of the bidders will be opened first. If all the required certificates, as stated are found in order, in their proper forms, then "Financial Bid" of the bidders will be opened. Tender of any contractor, not accompanied with proper Earnest Money, tender cost and/or tender, incomplete in any form, and shall be summarily rejected.

The magnitude of work may vary as per requirement of the Institute and will be finalized before awarding of the work. The Director, NIT Silchar reserves the right to award the job whole to one or may split among more bidder(s). Performance will be reviewed every 6 months for further continuation based on the report of the performance review committee of the Institute.



- c) Registration/Enrolment of Bidder on e-procurement Portal of NIT Silchar:

In order to submit the Bid, the bidders have to get themselves registered online on the e-Procurement portal of National Institute of Technology, Silchar with valid Digital Signature Certificate (DSC) issued from any agency authorized by CCA and which can be traced up to the chain of trust to the Root Certificate of CCA. The registration should be in the name of bidder, whereas DSC holder may be either bidder himself or his duly authorized person.

The bidders will have to accept unconditionally the online user portal agreement which contains the acceptance of all the Terms and Conditions of NIT (Notice Inviting Tender) including Commercial and General Terms & Conditions and other conditions, if any, along with on-line undertaking in support of the authenticity of the declarations regarding the facts, figures, information and documents furnished by the Bidder on-line in order to become an eligible bidder. No conditional bid shall be allowed / accepted.

The bidder will have to give an undertaking online that if the information/declaration/scanned documents furnished in support of the same in respect of eligibility criteria are found to be wrong or misleading at any stage, they will be liable to be punitive action.


Bidders are also free to communicate with the contact person of the service provider to get all clarifications regarding the mode of the e-procurement process.

Bidders should download the complete NIT including the Annexure and read carefully before filling the details and uploading the documents.




1) The bidder must upload all the documents required as per the terms of NIT. Any other document uploaded which is not required as per the terms of the NIT shall not be considered.
